This supplement ("**Supplement**") is supplemental to, and should be read in conjunction with, the Base Prospectus dated 18 August 2005 (the "**Base Prospectus**") prepared in relation to the €75,000,000,000 Euro medium term note programme of Dexia Municipal Agency (the "**Issuer**"). On 18 August 2005, the *Commission de Surveillance du Secteur Financier* (the "**CSSF**") approved the Base Prospectus as a base prospectus for the purposes of Article 5.4 of Directive 2003/71/EC (the "**Prospectus Directive**") and Article 8.4 of the Luxembourg Law on prospectuses for securities dated 10 July 2005 (the "**Luxembourg Law**").

The Issuer accepts responsibility for the information contained in this Supplement. The Issuer declares that, having taken all reasonable care to ensure that such is the case, the information contained in this Supplement is, to the best of its knowledge, in accordance with the facts and does not omit anything likely to affect the import of such information.

Unless the context otherwise requires, terms defined in the Base Prospectus shall have the same meaning when used in this Supplement.

On 28 September 2005, the Issuer published its interim financial statements with a limited review from the Auditors as at, and for the six months ended, 30 June 2005 (together with the related notes and the Auditors' report on the limited review of the interim financial statements, the "**30 June 2005 Interim Financial Statements**") which have been filed with the CSSF and such 30 June 2005 Interim Financial Statements are incorporated in, and form part of, this Supplement.
