#### Amended and Restated Final Terms dated 22 April 2024

These Amended and Restated Final Terms amend and restate the Final Terms dated 4 April 2024 relating to the *Obligations Foncières* (as defined below).

PRIIPS REGULATION - PROHIBITION OF SALES TO EEA RETAIL INVESTORS - The Obligations Foncières are not intended to be offered, sold or otherwise made available to and should not be offered, sold or otherwise made available to any retail investor in the European Economic Area (the "EEA").
